In consideration of allowing the Youth to participate in events sponsored by the Church and the Program, the Youth and, if the Youth is under the age of 18, the consenting parent or legal guardian of the Youth (collectively referred to as the "Participant") agree to sign this Release and acknowledge that the Youth is voluntarily participating in activities sponsored by the Church, including, without limitation, the Program and the Participant is assuming all risks and responsibilities associated with this participation.

Activities of the Program regularly include, without limitation, some or all of the following:

- (a) "Mall crawls" at various public malls throughout the City of Winnipeg;
- (b) "Car rallies" where drivers include licensed student participants;
- (c) Sports activities, including without limitation, tobogganing, skating, down-hill skiing, cross-country skiing, skateboarding, rollerblading;



- (d) Swimming activities;
- (e) "Sleepover" activities or camping activities;
- (f) High energy, large group games, including without limitation, Gargon, capture the flag, Jailbreak, and flour tag.

The Participant understands and agrees that these activities involve an element of risk and danger of accidents and that the Youth will not be directly supervised at all times, and, knowing those risks, the Participant hereby assumes those risks.

The Participant agrees that it is the responsibility of the Participant to inform themselves of the Program's scheduled activities and make inquiries of the Program's volunteers, or advise the Program's volunteers in writing, if there are any concerns about an activity or if additional information related to the Youth's ability to participate in an activity is required by the Participant.

By signing this Release, the Participant releases and discharges the Church and its deacons, trustees, directors, officers, employees, volunteers, representatives and agents and the Program's volunteers, representatives, agents and other participants (the "Released Parties") from any and all claims, damages and loss relating to injury, death, or property damage arising from or connected with participating in activities sponsored by the Church or related to the Program. This Release is intended to release and discharge the Released Parties from any and all liability arising out of, or connected in any way with, the Youth's participation in such activities, even though liability may arise out of negligence or carelessness on the part of one or more Released Parties.

Furthermore, by signing this Release, the Youth, and if the Youth is under the age of 18 years or age, the parent or legal guardian of the Participant hereby:

1. consents to the Youth participating in activities sponsored by the Church and (or) in any way related to the Program;
2. confirms that the Youth is physically able to, and has the maturity to, participate in all activities of the Program;
3. agrees to arrange, and be responsible for, transportation to and from activities related to the Program;
4. agrees to keep informed of the activities of the Program and advise the Program's volunteers of any concerns, in writing;
5. agrees to indemnify and hold the Released Parties harmless from any claims, damages or loss which any of them may incur as a result of the death or injury or property damage that the Youth may sustain while participating in such activities.

This Release and Indemnity is binding on the Participant's heirs, executors, administrators and assigns.

Each of the undersigned acknowledges and agrees that they have carefully read this Release and indemnity and fully understand its contents. Each of the undersigned is aware that this Release and indemnity is legally binding and is signing it of their own free will.
